Description:

PLASTCONE AP 430 is based on Sulphonated Naphthalene Polymers and supplied as a brown liquid instantly dispersible in water. PLASTCONE AP 430 has been specially formulated to give high water reductions without loss of workability or to produce high quality concrete of reduced permeability.

Uses:

- To produce dense and impermeable concrete
- In all types of low and high rise buildings
- In congestion reinforcement and where vibration is difficult
- To produce high strength concrete, Ready-mix concrete, high performance concrete etc.
- To produce concrete which can be transported over a long distance
- To produce homogenous and cohesive concrete without tendency of segregation and bleeding

Application Procedure:

PLASTCONE AP430 can be added into the mixing water or directly into the concrete mixture after 50-70% of the mixing water has been added. The addition of PLASTCONE AP430 to dry aggregates or cement is not recommended. To achieve optimum performance a minimum wet mixing time, which is depending on the mixing conditions and the mixer performance, of 60 seconds is recommended.

Dosage Range:

The optimum dosage of PLASTCONE AP430 to meet specific requirements should be determined by trials using the materials and conditions that will be experienced in use. The normal dosage range is between 0.8 to 1.2 % of cement.

Limitation:

- Excessive water addition or overdosing may cause bleeding or segregation.
- If frozen / separation of the product has occurred, Redwop PLASTCONE AP430 may be used after thawing slowly at room temperature and intensive mixing. Before application, suitability tests must be performed.

Compatibility:

PLASTCONE AP430 is supplied in 250 kg drums.

Storage & Shelf-Life:

PLASTCONE AP430 has a minimum shelf life of 12 months provided the temperature is kept within the range of 2 °C to 50 °C. Should the temperature of the product fall outside this range then contact Redwop office for advice.
