Reference: - Offline Proposal for invitation of the vender approval letter no. MSIDC/GN /387 /2025 dated 24.03.2025.

With reference to the above subject, certain manufacturers have expressed interest in supplying construction materials or products for the works undertaken by the Maharashtra State Infrastructure Development Corporation (MSIDC) for ongoing HAM and building works.

It is proposed that construction materials or products be incorporated into HAM (Hybrid Annuity Model) Projects to enhance carbon credit generation and foster green infrastructure development.

This includes various concrete road products such Cement, Reinforcement Bars, Reinforcement Protection coating Concrete fiber, Paints, Construction Chemicals, Construction Materials, Building Materials and Precast products used in PQC concrete roads, which were scrutinized by HQ, MSIDC and shortlisted as Preferred Vendor for MSIDC HAM Projects.

Inform it is to that MSIDC has approved products for A and B Category (Category restricted only for Cement and Reinforcement) based upon Project costing 50 Cr. And below 50 cr. Respectively.

Inform it is to that MSIDC has approved products for I, II and III Category (Category restricted only for Construction Chemicals expect CDA) based upon Company Turnover, Asset and Profitability, Manufacturing facility/ factory details and working experience.

1. Category restricted for cement and Steel

- a) A category product qualifies for all project with MSIDC costing above 50cr.
- b) B category product qualifies for all project with MSIDC costing below 50cr

2. Category restricted for Construction Chemicals (apart from CDA)

- a) I category Construction Chemicals (apart from CDA) qualifies for all HAM projects with MSIDC for all category is based upon Company Turnover, Asset and Profitability, Manufacturing facility/ factory details and working experience.
- b) II category Construction Chemicals (apart from CDA) qualifies for all HAM projects with MSIDC up to 100cr., category is based upon Company Turnover, Asset and Profitability, Manufacturing facility/ factory details and working experience.
- c) III category Construction Chemicals (apart from CDA) qualifies for all HAM projects with MSIDC up to 50cr, category is based upon Company Turnover, Asset and Profitability, Manufacturing facility/ factory details and working experience.

Other products/materials such as Construction/ Building Materials, Paints, Glass Fiber Reinforce Polymer Rebar (GFRPR), Concrete fibre, Crystalline Durability Admixtures, GGSB and Precast Product.

GFRP approval and usage

- Use of GFRPR products shall be permitted only after prior approval from MSIDC.
- These products shall be used strictly for non-structural works, i.e. Divider, Utility drainage, etc.
- Incorporation of GFRPR products will be allowed only after final written approval by HQ, MSIDC.

GGBS Usage

- Only Ground Granulated Blast Furnace Slag (GGBS) shall be used.
- Flyash shall not be permitted under any circumstances.

Note: - Preferred vendor for supplying, Thorough verification of vendor documents will be carried out at the time of source approval by approved ITF. The document mandates a zero-tolerance policy for preferred vendors who submit forged or invalid documents.

Necessary action will be initiated against vendors in case of any discrepancies or malpractice.



Role and responsibility for Independent Testing Firm (ITF)

- 1. Source approval for various materials/ Products is as per SOP attached herewith.
- 2. Only MSIDC preferred vendors from vendor list are considered.
- 3. Tests carried out on sources & products are as per IRC guidelines/ MORT&H/ IS Code etc.
- 4. Invoice and LR copy of all the materials and products are to be verified at the time of delivery (Quantity & Quality) and record is maintained.
- 5. Test reports of material tested are to be uploaded on MSIDC Dashboard. Along with undertaking (Specimen Attached herewith)

All concerned EE's/AE's/ITF's are strictly instructed to incorporate products from the preferred list of vendors in HAM works.

This approval is subject to:

- 1. Compliance with relevant MoRTH/IRC/IS Codes & MSIDC Specifications.
- 2. Periodic review and re-verification of vendor performance by MSIDC/ITF.
