



1. Unless otherwise provided in the Contract, the material to be used in the works should be from the list of approved materials (Brand/Make).
2. The Engineer-in-charge shall be the final authority to decide the source (Brand/ Make) of the material from the list of approved materials. The contractor shall obtain prior approval of source of material from the Engineer-in-charge before placing any order for supply of the same for using in the works.
3. If for any material, the Brand / Make included in the list of approved materials is not available in the market, the Chief Engineer (Building), shall have the authority to permit other Brand/ Make of the material which are equivalent to the Brand/ Make included in the approved list.
4. Material of a brand/make, approved in this list, shall strictly conform to the specification /stipulation laid down /applicable in the contract and such material shall be allowed to be used only when found conforming to specification/standard on testing as per relevant IS codes or any other relevant standard.
5. Authority competent to approve draft NIT can add or delete brand/make name of any item of this list, if so, warranted for a particular project.
6. If approved make/brand name of any material is not included in this list of approved material, then such material shall be brought to the site for use in the work only with prior approval of the engineer in charge. (As per specification)
7. If at any point of time, it is observed that the performance of the product included in the approved list, is not satisfactory, the product shall be removed from the list of approved materials without prior notice.
8. This registration shall not be concluded as a certificate for advertisement of your product/s and for obtaining registration/ approval from any other authority.
9. This approved list of materials is valid upto **2 years** from the date of issue of this office memorandum or upto validity of BIS certifications (wherever required) whichever is earlier from the date of issue.
